All applications are due **no later than Friday, July 7**. Applications may be completed and mailed to P.O. Box 360, Scarborough, ME 04070, dropped off at 418 Payne Road in Scarborough, or emailed to comserv@scarboroughmaine.org with a follow-up call for the payment (if applicable).

- **Insurance**: Insurance is required for all food and drink offerings, as well as some activities with perceived liability. Parties must attach a certificate of insurance for at least \$400,000 to this application naming the *Town of Scarborough* as an additional insured party for the event date. Please contact Scarborough Community Services if you have any questions about insurance.
- Hours of Operation: Our event runs from 5:00 to 10:00 pm, with the band beginning a 7:00 pm and the fireworks beginning at approximately 9:15 pm. Trucks/carts must be in operation and manned from 5:00 to 10:00 PM but are welcome to set up as early as 11:00 am to serve lunch, if they so choose.
- **Set-up time:** Day of event, vendors may set up as early as 11:00 am.
- **Breakdown time:** Friday after the fireworks (approximately 10:00 pm). Breakdowns prior to the fireworks require prior authorization by the Director of Community Services
- Parking: Each vendor will be entitled to a designated parking area for their truck/cart, with additional surrounding space for food prep, customer area, etc. Additional vehicle parking will be located across the street in the Wentworth School parking lot.
- All applications must be approved, and the signed and approved application must accompany the vendor on the day of Summerfest.
- There may be a walk-through prior to the start of Summerfest to be sure vendors are selling what was approved. We will ask that all unapproved items be removed before the event begins.

and costs whatsoever, including but not limited to attorneys' fees and costs, for any and all personal injury, including death, and
property damage arising out of or related to Releasor's participation in the Event, including all acts of negligence of the Town and it
officers, officials, agents and employees in their official and individual capacities, or otherwise.
Releasor agrees to abide by the Town's rules for the Event, including providing to the Town prior to the Event an insurance police
insuring at least the substantive areas of liability and monetary limits of the Maine Tort Claims Act and naming the Town as a
additional insured.
